

## BATAVIA TOWNSHIP TAX LEVY ORDINANCE

#### BATAVIA TOWNSHIP ORDINANCE NO. L2022 – 2023

An ordinance levying taxes for all town purposes for Batavia Township, Kane County, Illinois, for the tax year 2022, collectable in 2023.

BE IT ORDAINED by the Board of Trustees of Batavia Township, Kane County, Illinois, as follows

**SECTION 1:** That the sum of One Million, Two Hundred Ninety-four Thousand Dollars (\$1,294,000) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

GENERAL TOWN FUND
GENERAL ASSISTANCE FUND
MENTAL HEALTH 708 FUND

**SECTION 2**: That the amount levied for each object and purpose shall be as follows:

**SECTION 4:** That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

**SECTION 5:** That this ordinance shall be in full force and effect after its adoption, as provided by law.

I. A public hearing to approve a proposed property tax for Batavia Township for 2022 will be held on December 13, 2022, at 6:50 p.m. at 131 Flinn Street, Suite C, Batavia II. 60510.

II. The corporate and special purpose property taxes for 2022 were \$1,186,713.00.

The proposed corporate and special property taxes to be levied for 2023 are \$1,294,000.00.

This represents a 9% increase over the year.

III. The property taxes extended for debt service and public building commission leases for 2022 were 0.

The estimated property taxes to be levied for debt service and public building commission leases are 0.

This represents a 0% increase over the previous year.

IV. The total property taxes extended for 2022 were \$1,186,713.00. The estimated total property taxes to be levied for 2023 are \$1,294,000.00. This represents a 9% increase over the previous year.
